**[PROPOSED] ORDER AWARDING PLAINTIFFS' COUNSEL ATTORNEYS' FEES  
AND REIMBURSEMENT OF EXPENSES AND  
PLAINTIFFS' CASE CONTRIBUTION AWARDS**

This matter having come before the Court on **April 4, 2025**, on the application of Class Counsel for an award of attorneys' fees and reimbursement of expenses incurred in the Action and for Case Contribution Awards for the Plaintiffs, having considered all papers filed and proceedings conducted herein, having found the settlement for this Action to be fair, reasonable and adequate and otherwise being fully informed in the premises and good cause appearing therefore:

**IT IS HEREBY ORDERED AND ADJUDGED:**

1. All of the capitalized terms used herein shall have the same meanings as set forth in the Class Action Settlement Agreement (“Settlement Agreement”) executed on August 23, 2024, and filed with the Court on October 11, 2024. (ECF No. 184-01).


2. This Court has jurisdiction over the subject matter of this application and all matters relating thereto, including all members of the Settlement Class.

3. Plaintiffs’ Class Counsel are hereby awarded attorneys’ fees of **\$449,955.00** and reimbursement of expenses in the sum of **\$150,000.00** (the “Attorneys’ Fees and Expenses”), to be paid from the Gross Settlement Amount. The Court finds that the amount of fees awarded is appropriate and that the amount of fees awarded are fair and reasonable given the substantial risks of non-recovery, the time and effort involved, and the result obtained for the Settlement Class.

4. Plaintiffs Gregor Miguel and Amanda Bredlow are <sup>each</sup> awarded **\$10,000** as a Case Contribution Award, as defined in the Settlement Agreement, in recognition of their contributions to this Action.

5. Plaintiffs Chris Simonelli, David Villareal, Joseph Douillard, Marc Runyard, Mark Tracey and Robert Ramirez are <sup>each</sup> awarded **\$2,500** as a Case Contribution Award, as defined in the Settlement Agreement, in recognition of their contributions to this Action.
